City National Bank has branches and ATMs located in California, the District of Columbia, Florida (where the bank does business as “CN Bank”), Georgia, Nevada, New York, Tennessee, and Virginia. Based on the distribution of loans in relation to lending offices, the Bank has established the following community delineations:

**GEOGRAPHIES SERVED – CALIFORNIA**

**LOS ANGELES CNTY – ORANGE CNTY ASSESSMENT AREA (MD 31084 & 11244)**

CNB offices located in Los Angeles County and Orange County serve all census tracts within the two contiguous counties, each a Metropolitan Division, which together make up a complete MSA.

**OAKLAND ASSESSMENT AREA (MD 36084)**

CNB offices located in the East Bay area serve all census tracts within Alameda County and Contra Costa County (contiguous counties making up a complete MD).

**RIVERSIDE – SAN BERNARDINO ASSESSMENT AREA (MSA 40140)**

CNB offices located in the Riverside – San Bernardino area serve all census tracts within Riverside County and San Bernardino County (contiguous counties making up a complete MSA).

**SAN DIEGO ASSESSMENT AREA (MSA 41740)**

CNB offices located in the San Diego area serve all census tracts within San Diego County.

**SAN FRANCISCO – SAN MATEO ASSESSMENT AREA (MD 41884)**

CNB offices located in San Francisco and Burlingame serve all census tracts within San Francisco County and San Mateo County (contiguous counties making up a complete MD).

**SANTA BARBARA ASSESSMENT AREA (MSA 42200)**

CNB has a deposit-taking ATM in Santa Barbara County, but no deposit-taking branches. As required by the new CRA Regulation, the AA has been expanded from the City of Santa Barbara and now consists of all census tracts within Santa Barbara County.

**SANTA CLARA COUNTY (SAN JOSE) ASSESSMENT AREA (MSA 41940)**

CNB offices located in Palo Alto and San Jose serve all census tracts within Santa Clara County.

**VENTURA COUNTY ASSESSMENT AREA (MSA 37100)**

CNB offices located in the Oxnard – Ventura area serve all census tracts within Ventura County.

**GEOGRAPHIES SERVED – DISTRICT OF COLUMBIA**

**WASHINGTON DC ASSESSMENT AREA (MD 47894)**

CNB office located in Washington DC serves all census tracts within the District of Columbia (part of a multi-county MD). Note that the District of Columbia is considered a county equivalent by the Census Bureau and the Office of Management and Budget.

**GEOGRAPHIES SERVED – FLORIDA**

**MIAMI ASSESSMENT AREA (MD 33124)**

CNB office located in Miami serves all census tracts within Miami-Dade County. Note that in the state of Florida, City National Bank does business as “CN Bank”, due to the presence of another, unrelated, institution named “City National Bank” which is headquartered in Miami.

**GEOGRAPHIES SERVED – GEORGIA**

**ATLANTA ASSESSMENT AREA (MSA 12060)**

CNB offices located in Atlanta serve all census tracts within Fulton County and DeKalb County (contiguous counties within a multi-county MSA)

## **GEOGRAPHIES SERVED – NEVADA**

### **LAS VEGAS ASSESSMENT AREA (MSA 29820)**

CNB offices located in the Las Vegas area serve all census tracts within Clark County.

## **GEOGRAPHIES SERVED – NEW YORK**

### **LONG ISLAND ASSESSMENT AREA (MD 35004)**

CNB office located in Melville serves all census tracts within Nassau County and Suffolk County (contiguous counties making up a complete MD).

### **NEW YORK COUNTY – KINGS COUNTY ASSESSMENT AREA (MD 35614)**

CNB offices in Manhattan serve all census tracts within New York County and Kings County (part of a multi-county MD).

## **GEOGRAPHIES SERVED – TENNESSEE**

### **NASHVILLE ASSESSMENT AREA (MSA 34980)**

CNB office located in Nashville serves all census tracts within Davidson County (part of a multi-county MSA).
