Interest Rates and Interest Charges

*The Prime Rate means the highest U.S. Prime Rate as published in the “Money Rates” section of *The Wall Street Journal* on the last business day (Monday through Friday, excluding federal legal holidays) of the month. The Prime Rate current within the last 30 days is 8.50%. We add a margin of either 11.75% or 15.75% to the Prime Rate to determine the APR for Purchases and Balance Transfers, based on your creditworthiness. We add a margin of 17.75% to the Prime Rate to determine the APR for Cash Advances.

¹We are not offering Balance Transfers currently. However, in the future, we may, from time to time and at our option, permit you to obtain Balance Transfers.
